
### The future of the forest is in our hands!

# Portage County Hans Schabel Woodland



### Hans Schabel Woodlands

## Ecological Landscape of WI: Central Sand Hills

Hans and his partner purchased this 50 acres of farmland in 1978 with the intention of restoring the land and creating an enriching space to raise their family. The Schabel Woodland is located in Portage County between the Plover and the Tomorrow/Waupaca Rivers. It is uniquely located in Wisconsin's Tension Zone, which means it supports a diverse set of species from the southern and northern parts of the state.

Over the past 40 years, Hans, a former University of Wisconsin-Stevens Point forestry professor, has managed his property following the Dauerwald concept. Dauerwald is a German word which means "permanent, perpetual, continuous, or sustainable forest." Hans' strategy was based on uneven-aged silviculture and required "major restoration efforts that recreate forests which closely express their natural potential in structure, composition, and stability while meeting various product and service functions." Essentially, Han's wanted to convert the pastures, alfalfa fields, and poorly managed woodlot to its former, pre-colonial state. Some of the techniques Hans has utilized include removal of invasive species, selective timber harvests, and strategic tree planting.

Today, the property has more than 40 species of coniferous and deciduous trees. This includes hemlock, white pine, red pine, spruce, burr oak, basswood, sugar maple, red maple, elm, birch, and aspen. Hans has also successfully planted his favorite tree, juneberry. The property also supports a variety of wildlife species including deer, small mammals, and a variety of birds.
